The Directorate of Higher Education (DHE) was carved out of the

Directorate of Education in the year 1996 with an objective to provide

quality higher education to stakeholders irrespective of their caste, creed,

sex, race, religion, region, urban and rural.

Soon after Goa's liberation in 1961, a few colleges started and were

affiliated with Bombay University. Most colleges flourished in the state

during the 90's after the establishment of Goa University in 1984. Today

from north to south and west to east, almost every taluka is dotted with

Higher Educational Institutes (HEI) as a result of which the Literacy and

Gross Enrolment Ratio (GER) of the State have increased substantially.

The Directorate of Higher Education supports higher education in various

streams such as Arts, Commerce, Science, Education, Law, Journalism, Mass

Communication, Agriculture, Nursing, Vocation, Business Administration,

Music, Home Science, Fine Art, Theatre Arts, Hospitality, and Fashion.

Presently, the Directorate of Higher Education is involved in the planning,

administration and funding of 39 Higher Education Institutions (HEIs)

which includes 07 Government Colleges, 31 Non-Government Aided

Colleges and the Goa University. Of the 39 Higher Educational Institutions,

25 HEIs are NAAC Accredited, and 7 Colleges have undergone 4th Cycle of

NAAC which is a remarkable achievement for the State of Goa. About 32 per

cent of the NAAC-assessed Colleges have achieved 'A+' or 'A' grades.

The following are the Functions and Duties of the of the Directorate of

**Higher Education:** 

a) Service cadre & Budget controlling Department for teaching and

non-teaching employees to the seven Government Colleges.

b) Deals with the service matters of the teaching and non-teaching

employees of these Government colleges.

c) Deals with the grants-in-aid to be provided for the purpose of

payment of salary of 31 Government aided Colleges affiliated to

Goa University and loan facilities for up gradations of

Infrastructure.

d) Deals with the sanction of GPF advance/withdrawal/final payment

to the teaching and nonteaching employees of Goa University and

Government Colleges as well as Government Aided Colleges to Goa

University.

e) Deals with the pension cases of Goa University and Aided Colleges.

f) Deals with the issue of administrative NOC to the Goa University

and Government Colleges as well as Non-Government Aided

- Colleges affiliated to Goa University for filling up of the teaching as well as non-teaching posts in the respective institutions.
- g) Deals with the proposals regarding condonation of break-in-service and counting of past service for the purpose of pensionary benefits in respect of the teaching and non-teaching staff of the Goa University and Government Colleges, as well as Government, aided Colleges affiliated to Goa University.
- h) Deals with the maintenance of a model post-based roster of various teaching/non-teachings posts in the Goa University and 31 Government Aided Colleges affiliated to Goa University.
- i) Conduct audit of 31 Non-Government Aided Colleges affiliated to Goa University.
- j) Discharges the functions of Budget Controlling Authority in respect of the Government funds to be released to the Goa University and Non-Government Aided Colleges affiliated to Goa University.
- k) Authentication of Educational Certificate: The Educational Certificates issued by the Goa University in respect of the degree courses and above, imparted by Aided as well as Government Colleges under the jurisdiction of this Directorate are authenticated by this Department in respect of students going abroad for employment or higher studies. The Authentication is done on behalf of the Ministry of Human Resource Development and Ministry of External Affairs, Government of India, New Delhi.
