CIRCULAR

Read:- This Department's Circular Nos.

1. 2/137/2017-18/Ph.D/M.phil/Circular/DHE/3100 dated 04/01/2018.
2. 2/137/2017-18/Ph.D/M.Phil/Circular/DHE/4307 dated 21/03/2018.

This Department vide above referred Circular has circulated a checklist to be followed while submitting the proposal for grant of Ph.D/M.Phil increments. As per point No. 6 of the checklist "copy of certificate from the concerned University stating that the Ph.D/M.Phil is relevant for teaching of the respective subject" is required to be submitted.

Goa University has requested this Department that the relevant certificate may not be insisted where the Ph.D is obtained by the faculty in the discipline of his/her specialisation at Master's Level and in the subject of his/her teaching alongwith the Ph.D guide/supervisor from the same discipline.

The matter has been re-examined and it is clarified that the relevant certificate need not be submitted if "the Ph.D is obtained by the faculty in the discipline of his/her specialization at Master's Level and in the subject of her/his teaching alongwith the Ph.D guide/supervisor from same discipline. Only a certificate from the Principal to this effect may be submitted. In all other cases relevant certificate needs to be submitted from the University".

In case of Ph.D obtained from a foreign university, the DHE will constitute a Committee to certify the relevance.
